After the Korean War began, we tried to escape southwards but could not because the Han River Bridge
was destroyed. My father at the time was tasked with mainly seeking out communists, and because of that those he
ocked up sometimes tried to take revenge on him. As a result, the family all hid at a relative's house in Mapo-gu
Communists were going around the neighbourhood, taking people away and doing other bad things, so we had no
choice but to run away. However, there were communists everywhere we went. Eventually we were caught. Two
agents from either the Political Security Department or Department of Internal Affairs armed with handguns stormed
where we were staying and took my father away. We heard nothing about him after that.
Rumour has it that my father was held in the National Library building, which was the Political Security
Department headquarters at the time. There were tons of families waiting in front of the building there. There was
small window on the third floor and the prisoners were allowed to stick their heads out of the window one by one and
write something on paper their families could see. There were a lot of families there waiting to see if they could catch
a glimpse of their loved one.
We also went to find our father, but failed to see him. When Seoul was returned to the South Korean army
we returned home but our father was not there. The dog we had cared for was gone, all the drawers were opened and
every document in the house had been carried away. There were no pictures left, including the one my father had take
with his secretaries at the court. The communists had taken everything to destroy the evidence.

I think the North was so short in labor they took skilled laborers to use in their workforce. However, those
who had worked in the courts or in the government were probably killed outright. They were probably subject to
torture, and given the communists' poor food supply, they probably did not help the abductees survive.
In any case, my father was taken away because he was a high-level government official who supported
liberal democracy, not the ideology of the Communist Party. After the Incheon Landing, we followed the soldiers up
to Seoul and headed to the Seodaemun Prison. We did not find my father there, and instead found about 40 corpses.

i) In 1956, the Korean National Red Cross registered infrmation on abductees through their family members
and compiled a list for the International Committee of the Red Cross to submit to North Korea, to find out about these
'displaced civilians' whereabouts. Mr. Kim Yu-yon's case was also registered by his family, but the family have never
received any reply or information on his whereabout.
ii) Also on June 25-Aug 31, 1964, the Chosun tribune newspaper and Korean National Red Cross
collaboratively carried out a "One million signature-collecting campaign for Korean War Abductees' Repatriation",
and it was submitted to the United Nations, but turned down because the wartime civilian issues were deemed to fall
under the jurisdiction of the International Committee of the Red Cross.
iii) In 2006, he claimed for compensation against Korean government, along with members of
KWAFU(Korean War Abductees' Family Union) whose abducted families were then government officials. They
accused ROK government of dereliction of its duty to protect its nationals at the time of Korean War. The
compensation has not been made yet.
iv) Dec 13, 2011, KWAFU advocates the drafting and passing of House Resolution 376, a U.S. congressional
House resolution

in trying to survive during the war. We suffered because there was no way to find him
